RULES: This tournament is restricted to USBC members or those non-members who purchase an unattached membership prior to bowling (\$16.00). The payment of a participation fee (\$5.00) will entitle the entrant to participate one time at the tournament where the fees are paid.

BOWLERS WITH A 2015-16 FINAL AVERAGE: Use the 2015-16 bowling season USBC final average of at least 21 games OR the final tournament average of at least 21 games from the 2015-16 Northeast Iowa Tournament. Bowlers will use the higher of the two averages for all district qualifying tournaments.

TOURNAMENT AVERAGE: USBC Rule 319A & D will apply to all participants. It shall be the responsibility of each bowler to verify the accuracy of his or her average. Rerate rule as

NEW BOWLERS ONLY: Bowlers without either of the above averages will be allowed to use their highest current average at the time of participation with a minimum of 12 games. A verification form from their league secretary or bowling center manager/owner with current average confirmation must be submitted at the time of entry. If this documentation is not presented, men will use an assigned average of 185 & women use 165.

ROLL OFF QUALIFYING: The same 5 persons CAN qualify twice for the roll-off but it must be at TWO different tournament sites. Once a team has qualified for the roll-off twice with the same 5 bowlers, they must change at least 2 bowlers at the district events to qualify for the roll-off again.

DISTRICT ROLL-OFF RULES:

The cost for the roll-off will be \$100 per team (\$58 prize fund; \$42 bowling & expenses).

Qualifying for the roll-off will be based on 1 out of 6 entries and any fraction at each local tournament site. The same 5 persons CAN qualify twice for the roll-off but it must be at TWO different tournament sites.

TEAM CASHING: The same 5 persons may collect only ONCE in the roll-off prize list. Teams must change 2 bowlers to cash more than once at the roll off. A maximum of 2 substitutes per team will be allowed at the roll-off.

AVERAGE: Bowlers will use the HIGHEST CURRENT league average at the time of participation with at least 21 games OR the highest 2014-15 USBC final average of at least 21 game OR the final average from the 2015-16 Northeast Iowa Tournament: whichever is highest of the three options.

Employees of the hosting bowling center are not eligible to participate in either of the individual events

Singles Jackpot - Individuals may enter BOTH the Handicapped and Scratch Singles by paying both entry fees (\$14 total). Individuals may cash only once in each event. **Prize Money returned 100%.**

Strikes-in-a-Row Jackpot: Enter only one Jackpot based on your average. An individual may win ONLY one time per tournament site. If the jackpot is NOT broken, the money will be carried over to the next tournament. Any strike jackpot money will be dispersed in the roll-off team prize list if jackpots are not broken during the roll-off.

Any rules not covered in these written or expanded version in the tournament packet, will be governed by USBC.
